## Terms

### Trust of Care

By signing this Grooming Contract, I entrust the care of my pet(s) to The Classy Coat, Alayna Kay, and agree to all the terms listed below.

### Rate of Pay

I agree to pay the rate for any grooming and special services requested, as well as needed per the groomer's expertise for the health and comfort of my pet. I further agree to pay all charges for any damage my pet has done to The Classy Coat, Alayna Kay's property. In the case that I fail to show, without 48 hour notice, for a service that I have scheduled, I agree to pay the \$25 no show fee.

### Pet Behavior

I agree that I am solely responsible for all behavior of my pet while in the care of The Classy Coat, Alayna Kay. I also understand that The Classy Coat, Alayna Kay will not preform services if my pet acts in an uncomfortable or aggressive manor and that this is best for my pet's well being.

### Pet Health

If my pet becomes ill or if the state of my pet's health otherwise requires professional veterinary services, I authorize The Classy Coat, Alayna Kay, in its sole discretion, to engage the services of a veterinarian , give medication, or give other requisite attention to the animal, and the expenses for this care is my responsibility and will be paid by me. I further hold harmless The Classy Coat, Alayna Kay for any accidental injury and/or illness my pet may incur while under its care.

**Parasite Agreement**

I agree that my pet will enter the property of The Classy Coat, Alayna Kay, without fleas, ticks, or any other external or internal parasite(s). I further understand that my pet will be inspected upon each arrival and if infested with any external or internal parasite upon inspection or if found at all throughout the period of which services are being performed, I am responsible for the immediate retrieval of my pet and will pay for the removal and clean up of said parasite on the property.

**Vaccination Requirement**

I agree that I am solely responsible to provide proper, up to date immunization records provided by my pet's veterinarian before scheduling grooming services, and that if I do not, services will not be provided to me and my pet until I do. These vaccinations include:

Dog: current DHLPP, Rabies, and Bordetella (yearly)

Cat: current Rabies, FVRCP/FELV (yearly)

**Pick Up and Abandonment Policy**

I agree to retrieve my pet within 30 minutes of completion of services by The Classy Coat, Alayna Kay. If I fail to do so, I understand that there will be an additional \$15 charge for every 30 minutes past the original given 30 minute time. I further understand that if my pet is not retrieved within 12 hours of the completion of service, my pet will be turned over to Porter County Animal Control and will be considered abandoned.
